The establishment of off-limits areas is a function of command used to help maintain good order and discipline, health, morale, safety, and welfare of personnel assigned and/or located at JBSA and/or in the Greater San Antonio area pursuant to the authority contained in the controlling Joint Instruction, *Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations* (AR 190-24; OPNAVINST 1620.2A; AFI 31-213; MCO 1620.2D; COMDTINST 1620.1E), 27 July 2006.
