SUBJECT: COVID-19 Self-Reporting General Order

1. This general order is applicable to all United States military personnel presently assigned to, or serving on, Joint Base San Antonio (JBSA), Texas. You are ordered to report any RQIP status, as well as positive Coronavirus Disease 2019 (COVID-19) test results, to your chain of command as soon as possible, but no later than 24 hours from notification. This includes notifications obtained at either a military or civilian treatment facility. Additionally, you must receive confirmation from the JBSA Restriction of Movement, Quarantine, and Isolation (RQI) Fusion Cell that you are no longer considered at risk for developing COVID-19 infection before release from any RQI status.
2. Department of Defense (DoD) civil service employees, contractors, and family members are highly encouraged to report any RQIP status, as well as positive COVID-19 test results, as soon as possible after notification. Civil service employees can report to their supervisory chain; contractor employees can report to their employer who, in turn, can report to the contracting officer representative; and family members can report to their sponsor, who can then report to their chain of command.
3. Paragraph 1 of this general order is punitive. Personnel subject to the Uniform Code of Military Justice (UCMJ) may face administrative, nonjudicial, or judicial action under Article 92 of the UCMJ for failing to obey this general order.
4. It is the DoD and Military Service policy that military installations, property, personnel, and other individuals working or residing on military installations, will be protected under applicable legal authorities against communicable diseases associated with biological warfare, terrorism, or other public health emergency. Moreover, as the JBSA Commander, I have a duty to promote and safeguard the morale, physical well-being, and the general welfare of persons under my command. Reporting RQIP status and positive COVID-19 test results allows us to create trace data that can be used to reduce the spread of COVID-19 and protect our military members, families, and local community.
5. Commanders and military and civilian supervisors are charged with ensuring that all personnel are briefed on the requirements of this general order, which remains in effect until superseded or rescinded. This general order supersedes the COVID-19 Self-Reporting General Order from 26 March 2020.
