SUBJECT: Patron Eligibility for Joint Base San Antonio Military Dining Facilities (DFAC)

1. In accordance with AFI 34-239, *Food Service Management Program*, 17 April 2014, attachment 2, all enlisted personnel are authorized to utilize the DFACs within JBSA. Additionally, the installation commander may authorize certain members of the force to utilize the dining facilities. As such, Commanders, Chief Master Sergeants, First Sergeants, Civilian Leaders, and officers/civilians who are part of a command team are herein authorized to consume meals to support their assigned Essential Station Messing (meal card holders) personnel.
2. Temporary Duty (TDY) members (officers, enlisted, and DoD civilians) receiving the meal portion of per diem and when TDY orders authorize use of the DFACs may use all facilities.
3. Other personnel authorized to use the DFACs:
  - a. Institutional Training Directed Lodging & Meals (ITDLM) students
  - b. First Responders (Military and civilians)
  - c. Chaplains, when ministering to personnel
  - d. Non-Medical Assistants (civilians assisting wounded warriors)
  - e. Personnel (enlisted/officers) in a PCS status and their family members may dine at the Rocco
  - f. DFAC on JBSA-Fort Sam Houston (Slagel when Rocco is closed)
  - g. Permanent party officers/DoD civilians may dine at the Rocco & Camp Bullis (Bldg 5107) DFACs
  - h. Active duty family members and military retirees and their family members may eat the traditional Thanksgiving/Christmas meals at designated JBSA DFACs
  - i. Designated guest(s) of the installation commander

4. Please note the following exceptions:

a. All DFACs designated for Basic Military Training at JBSA-Lackland are for use by Basic Military Trainees, their leadership, and cadre ONLY

b. The Defender Inn (Bldg 5420) and Medical Readiness Training Facility (Bldg 6361) at Camp Bullis are for use by AF-sponsored trainees, their leadership, and cadre ONLY

c. The Slagel DFAC at JBSA-Fort Sam Houston is for use by students, their leadership, and cadre ONLY (with the exception noted in paragraph 3e as well as permanent party ESM on weekends and holidays)

5. This letter supersedes all others, same subject.
